On October 1, 2017, over 22,000 festival goers came together to enjoy an open-air music festival (Route 91 Harvest) in Las Vegas, NV. On the final night of the festival, during the main event performance, a lone gunman rained gunfire down into the crowd from an elevated position from the 32nd floor of the Mandalay Bay Hotel and Casino. The gunman actively targeted concert attendees and workers for over ten minutes, resulting in the deaths of 58 innocent people and injuring approximately 887 others. With law enforcement closing in on his location, the gunman killed himself.

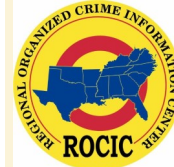
