We are preparing for our 17th annual **Kentucky Narcotics Officers' Association (KNOA) conference August 31, September 1, and 2, 2022 at the Downtown Hilton Hotel, Lexington, Kentucky.** The conference will begin at 1 P. M. on the 31st and end at 12 P. M. on the 2nd of September.
